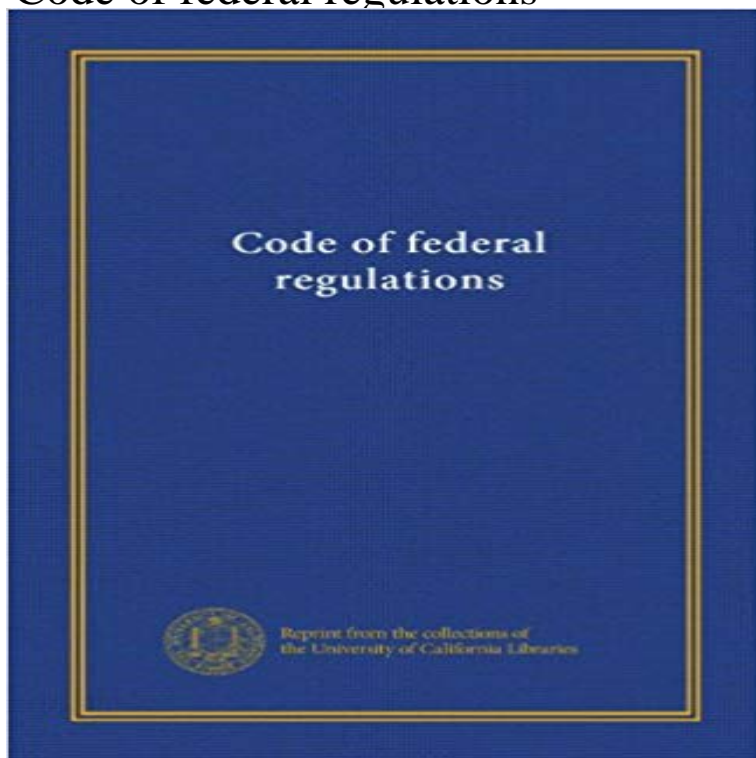


## Code of federal regulations
