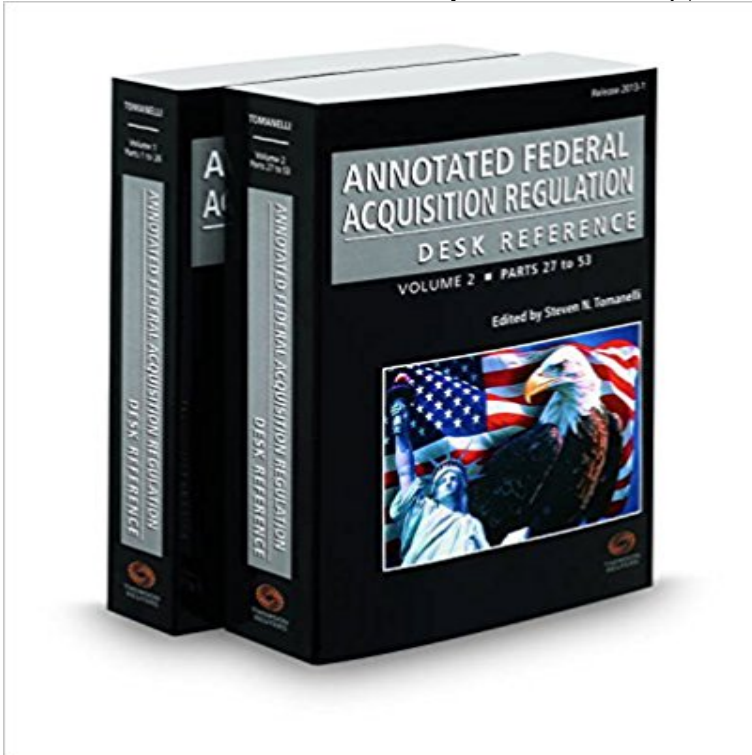


## Annotated Federal Acquisition Regulation Desk Reference, 2013-2 ed.
