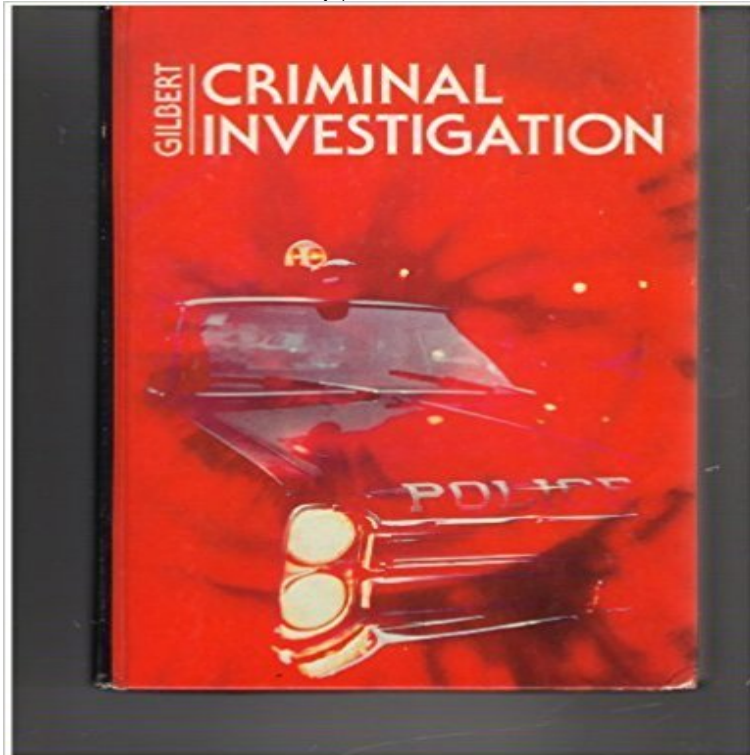


Criminal investigation
