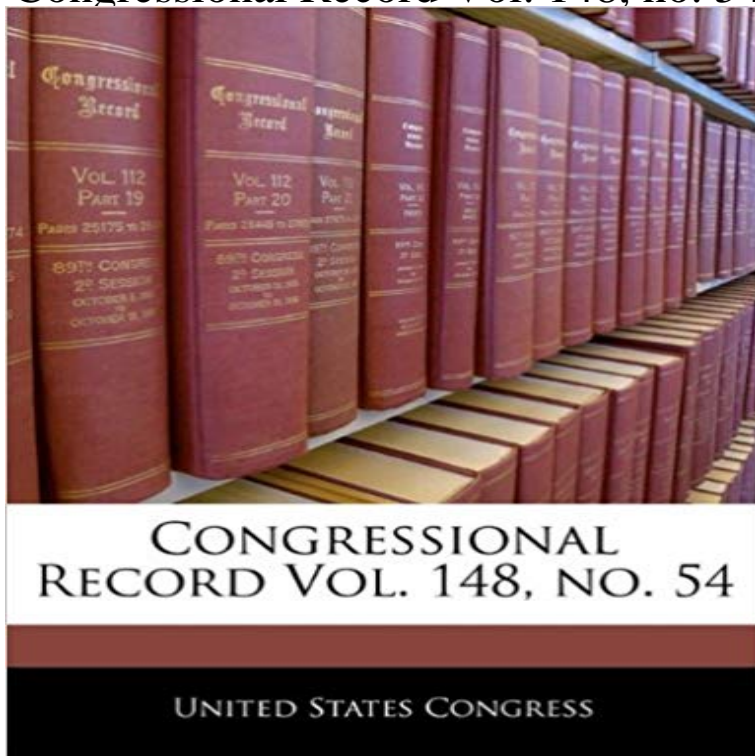


Congressional Record Vol. 148, no. 54
