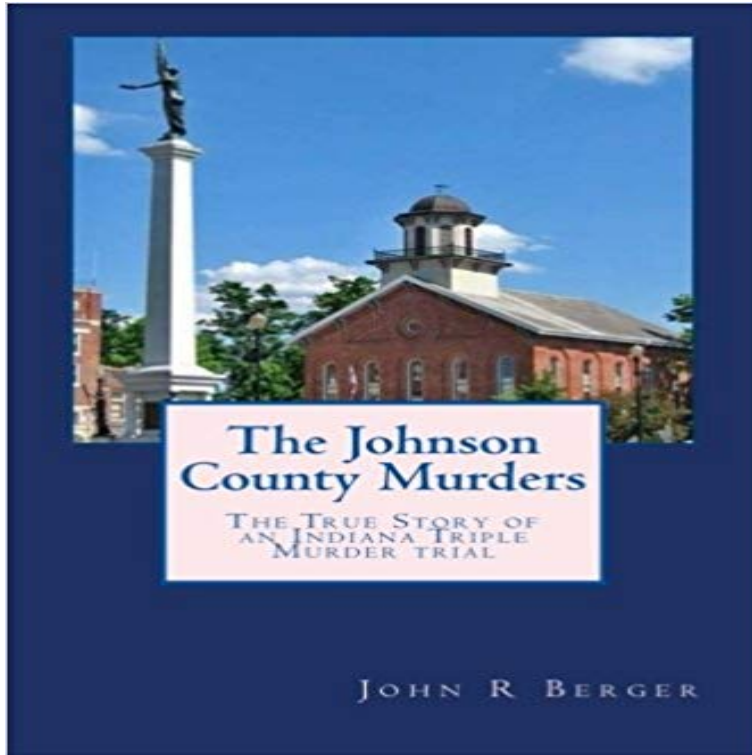


# The Johnson County Murders: The True Story of an Indiana Triple Murder Trial
