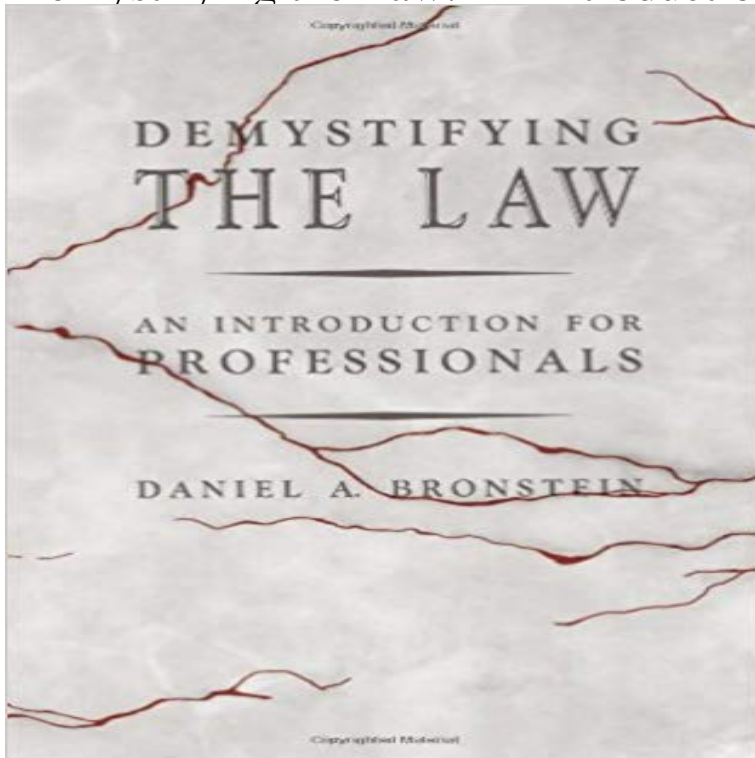


Demystifying the Law: An Introduction for Professionals
