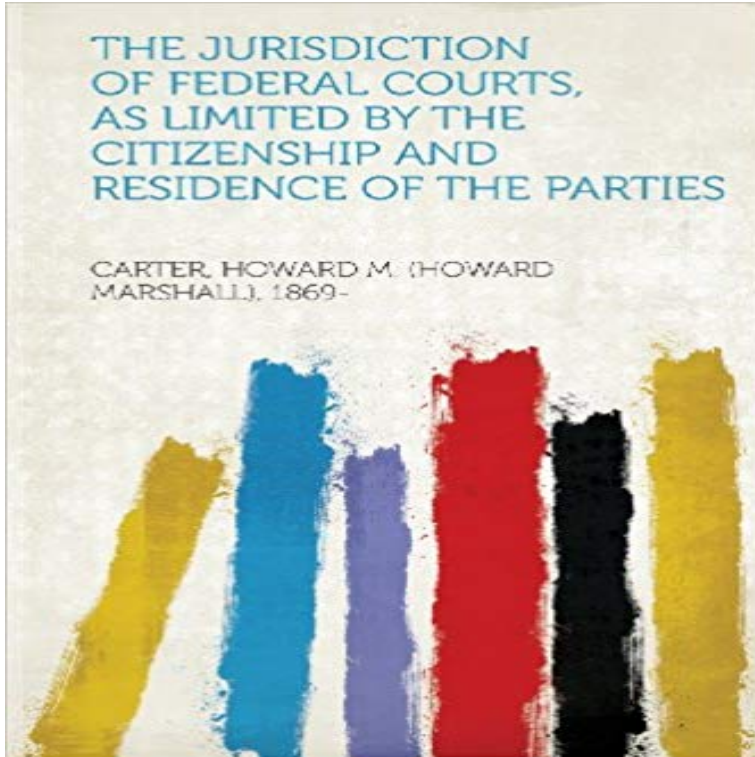


The Jurisdiction of Federal Courts, as Limited by the Citizenship and Residence of the Parties
