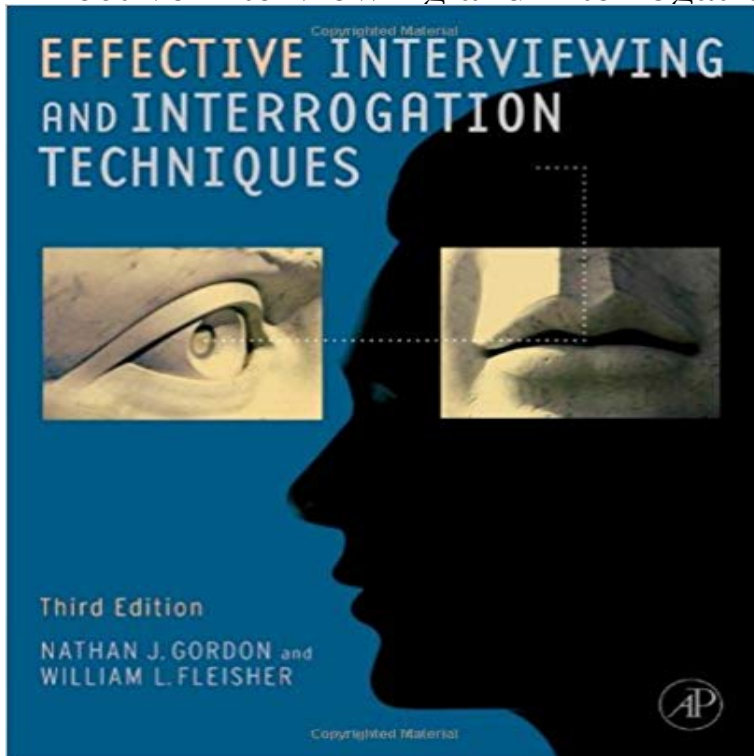


Effective Interviewing and Interrogation Techniques, Third Edition
