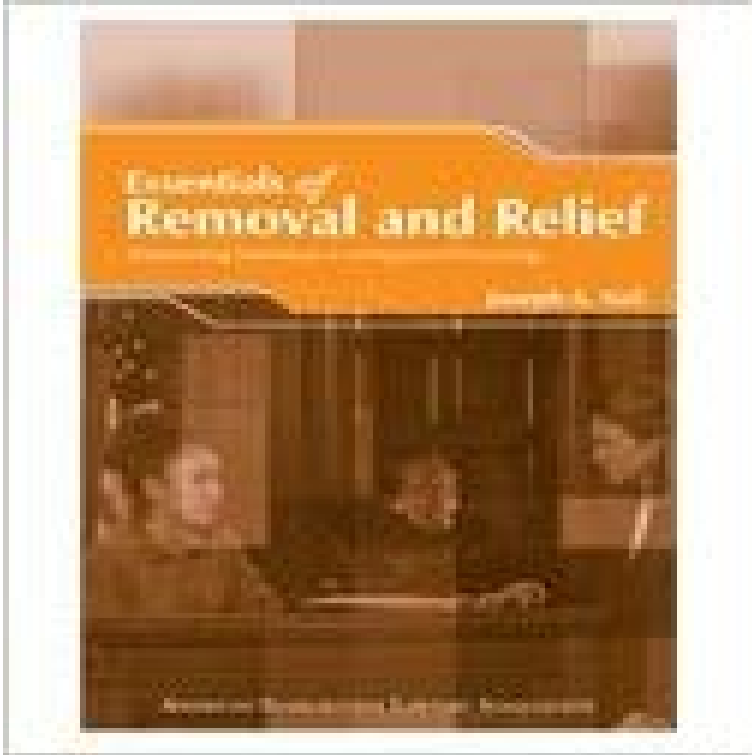


# Essentials of Removal and Relief: Representing Individuals in Immigration Proceedings
