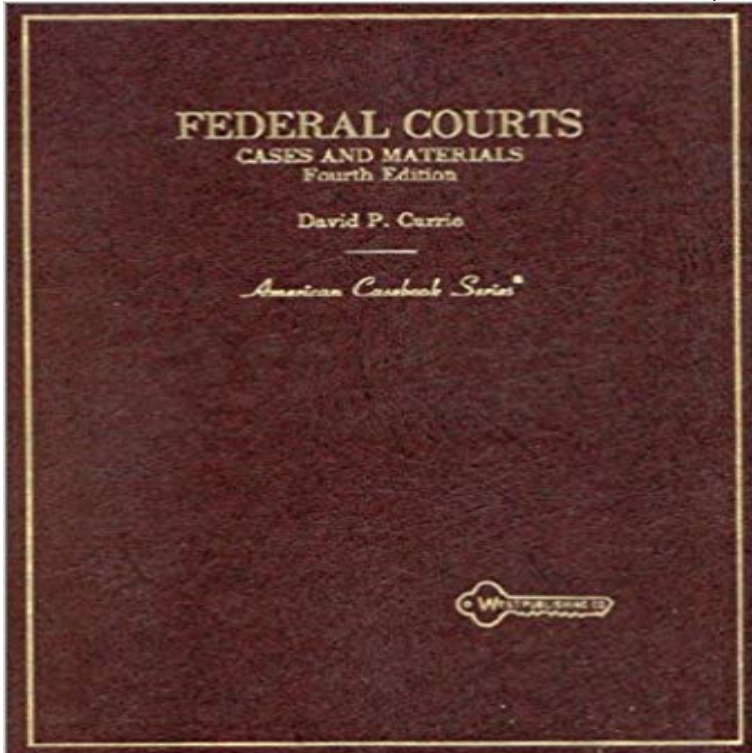


## Federal Courts: Cases and Materials, 4th (American Casebooks)

Deals with limitations on the exercise of jurisdiction that cuts across the various jurisdictional categories: sovereign and official immunities and a variety of statutory and judicial abstention doctrines. Follows the litigant into situations in which a federal court is asked to pass upon what another tribunal has already done.
