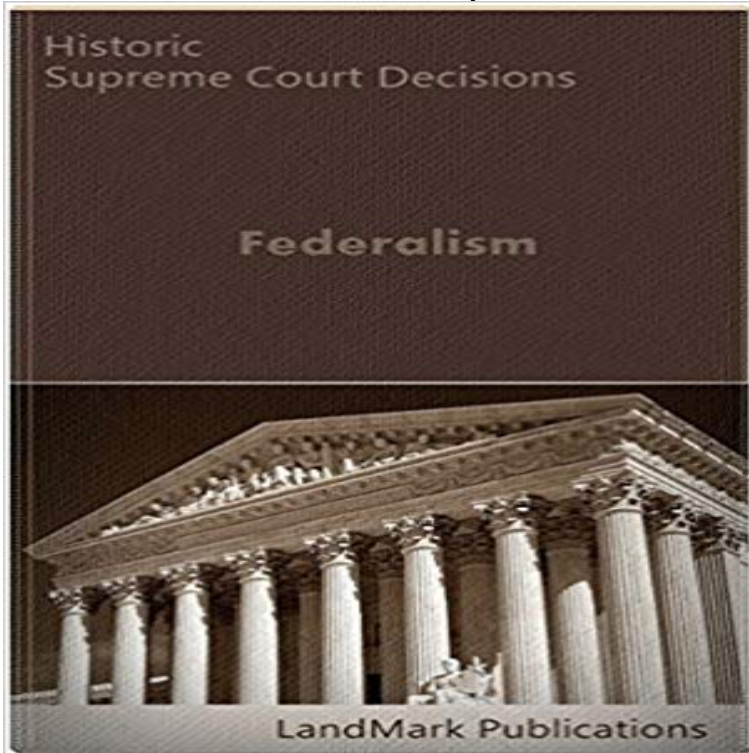


Federalism: Historic Supreme Court Decisions (LandMark Case Law)
