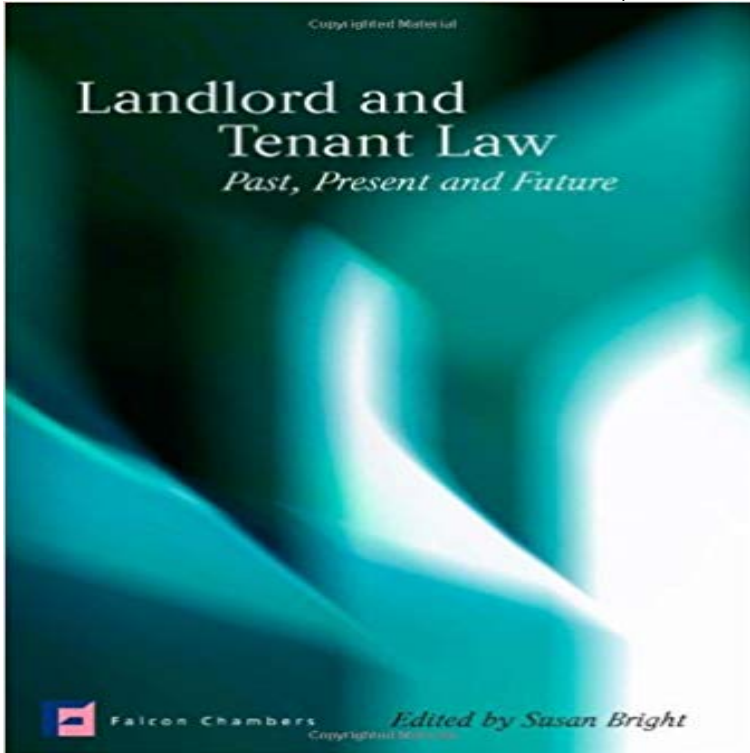


# Landlord and Tenant Law: Past, Present and Future
