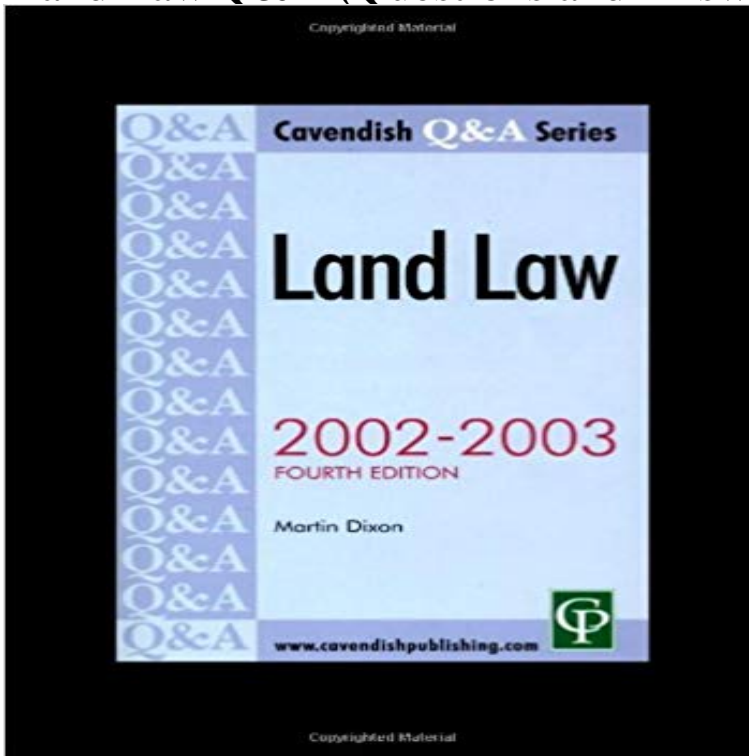


## Land Law Q&A (Questions and Answers)
