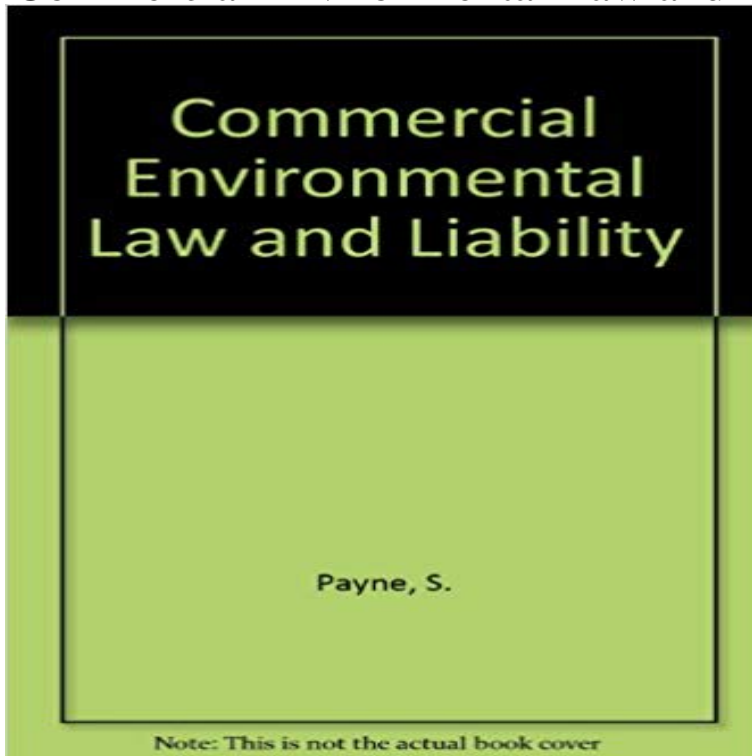


Commercial Environmental Law and Liability
