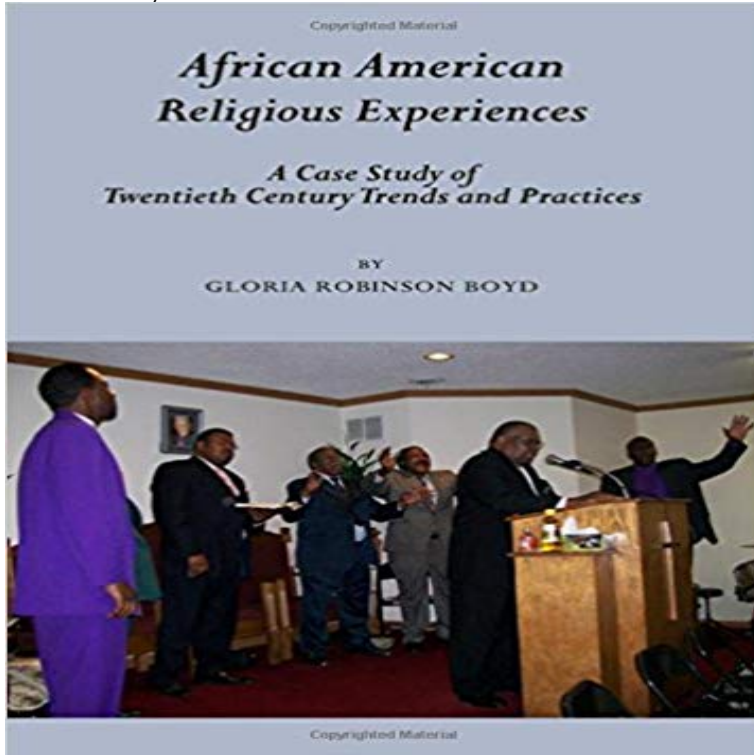


African American Religious Experiences: A Case Study of Twentieth Century Trends and Practices
