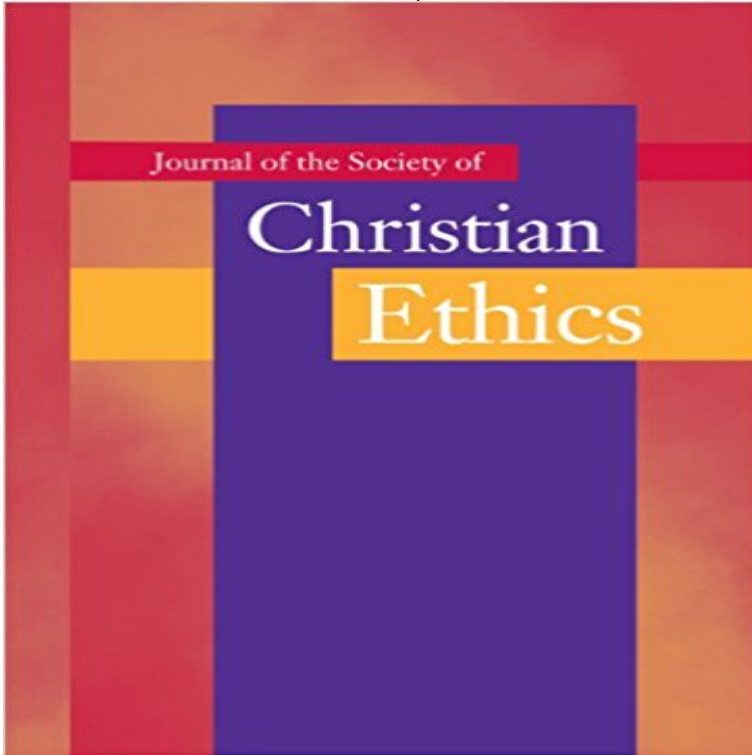


## Journal of the Society of Christian Ethics: Spring/Summer 2011
